# The Legal Status of Weapon Ownership in Russia

- The number of owners of civilian weapons 5,000,000 people (3% of the population)
- The number of weapons that are owned by civilians 6,250,000 units
- Authorized under a license for possession and hunting: guns, rifles.
- Authorized under a license for carrying: weapons of limited destruction (traumatic, firing rubber bullets), gas guns.
- Permitted without license: air guns up to 7.5 J, stun guns, gas sprays.
- Forbidden guns for citizens: pistols and revolvers, automatic weapons.



# The Legal Status of Weapon Ownership in Russia

- Civil arms are governed by the law "On Weapons"
- The right to self-defense is governed by Art. 37 of the Criminal Code

According to these articles, self-defense is only possible if it is a response to a threat to life or health of the defender or third parties. Self-defense must be proportionate to the attack.

# Problems

- The ownership of the most effective weapons for self-defense are prohibited pistols and revolvers.
- For rifles you must be the owner of a smoothbore gun with no problems with the law for at least 5 years.
- The laws of self-defense. As a result, it is impossible to protect life, health or property.
- Ban on Adrertisement concerning weapons.
- A large number of amendments to the law "On Weapons", the possibility of manipulation, especially in the production and trade of weapons, shooting objects. This increases the cost of services for gun owners.



Supporters of empowering citizens to own weapons in Russia, as a rule:

- Men from 35 to 55 years old,
- Residents of large cities,
- With higher education,
- High level of earnings.

Supporters of the right to own civilian weapons for certain categories of citizens (military, police, those who served in the military, journalists, and others) are already 39%.


- It was founded in 2010
- It is composed of 65 local offices



The organization places great emphasis on the exchange of experiences with organizations defending the rights of citizens to arms in other countries. The organization's management has signed cooperation agreements with similar organizations in Kazakhstan, Ukraine and Estonia.







#### Activities

Working with the authorities; the presentation of a scholarly paper in the Federation Council (upper house of Parliament), developed by an expert group chaired by the Deputy Chairman of the Federation Council Alexander Torshin.

 Development of bills, work with the deputies of the State Duma (the lower house of Parliament), the introduction of bills for consideration.

- We work with every journalist regardless of the context of the material
- All comments for the media are given to one person, who is the speaker and chairman of the organization. He is the diplomat for negotiation.
- Regular tournaments for journalists and

bloggers on how to handle weapons safely.





#### The Principle of Publicity

Regular "open letters" about the organization's position in regard to the events involving weapons (reform legislation, crimes with guns, selfdefense, etc.)

The initiative to establish contact with the media Representatives in every town and village. Lessons for the members in their ability to speak

## <sup>©</sup> The Principles of Democracy

- Organizations can join through different paths a member of the organization (fee), a supporter of the organization (for free).
- No barriers to enter into the organization (no need to own weapons, have certain political views.)
- No barriers to become active in the organization.
- Open account for charitable donations of money. The sum and the willingness to pay is up to the individual or organization.
- When a person becomes a member or supporter of the organization, he receives promotional materials to attract new members to the organization
- Initiation of new activities and projects from the start.
- Public discussion of the results of operations. Openness to constructive criticism.









© Working with the Government The main principle: "Opponents of responsible weapon ownership do not exist, there are only misinformed individuals."


- Regular monitoring of public appearances in the media, involvement of supporters with opponents with the aim of changing views.






Qualifying tournaments for the team. Speeches at the events. Conduction of competitions Shooting clubs in 12 regions
